

## Admissions Arrangements for 2027-2028

Walderslade and Greenacre (WGSP) are a co-educational provision for male and female students between the ages of 11-18 years of age.

This move to Co-educational provision best fulfils the need of the local community who feed into our school from co-educational settings, providing students with the best opportunities to thrive, belong and achieve and we believe a continuation to thrive in school is best served by continuing in mixed-sex environments.

We believe that moving to co-education represents a positive and forward-thinking step for our school community. This proposal aligns with the majority of schools in the local area, where co-educational learning has become the standard model. By joining this approach, we will be able to offer the best possible educational experience at every level and provide a more cohesive and inclusive learning journey within WGSP.

Research and guidance from the Education Endowment Foundation (EEF) suggest that co-educational environments can lead to improved social development, mutual respect, communication, and collaboration between students. These are essential skills that prepare young people for success in further education, employment, and wider life.

In preparation for this proposed change, we have already introduced successful co-educational trials across various areas of school life, including:

- Social times
- Transitions between lessons
- Clubs and enrichment activities

The response from students, staff, and the wider community has been overwhelmingly positive. These opportunities have encouraged greater cooperation, inclusivity, and understanding between pupils, and have enhanced the overall sense of community within WGSP.

The main principal of admission to Walderslade and Greenacre School is to maintain the character of the school as a local school serving its community. The school is an inclusive school that welcomes children from all backgrounds and abilities. There is no guarantee of a place for any child meeting our oversubscription criteria. Admission to our school is not dependent upon any 'voluntary' contribution.

Home address: Proof of residence will be required by the co-ordinated scheme. The offer of a place will be withdrawn if proof of residency is not met. Where a child lives part of the week with one parent and part with another member of the family, the 'home address' will be considered to be the residence where the child spends at least three nights of the school week each week. For clarity the school week runs from Sunday night to Thursday night inclusive.

## Admission into Year 7

The ability of a child or any special needs that s/he may have, plays no part in the admissions policy of this school.

Children due to be admitted during the Academic Year 2027/2028 are those born between 1<sup>st</sup> September 2015 and 31<sup>st</sup> August 2016.

The Published Admission Number (PAN) for the year commencing September 2027 will be 340.

Places are offered to pupils with Education, Health and Care Plans (EHCP) where, following consultation with the Local Authority that the child's individual needs can be met, the school is named.

### Oversubscription Criteria

Where the number of applications received via the Medway co-ordinated scheme exceeds the School's PAN, places will be allocated in the following priority order:

1. Looked after children, and all previously looked after children. The school participates in the Local Authority co-ordinated scheme and all deadlines within that should be adhered to by applicants. As required by the Regulations of 2005 the school will give the top priority in their oversubscription criteria to applicants on behalf of looked after children (A 'child looked after' is a child who is (a) in the care of the Local Authority, or (b) being provided with accommodation by a Local Authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989) at the time of making the application to a school) and previously looked after children. Previously looked after children are children who were looked after but ceased to be so because they were adopted (or became subject to a residence order or special guardianship order).
2. Children previously in Care outside of England - Children who appear to WGSP to have been in state care outside of England and ceased to be in state care as a result of being adopted. A child is regarded as having been in state care in a place outside of England if they were accommodated by a public authority, a religious organisation or any other provider of care whose sole purpose is to benefit society.
3. Current family association (a sibling in the school at the time of application and still attending in September 2027). Sibling means children who live as brother/sister in the same house and includes natural siblings, adopted siblings, foster siblings and step siblings. Extended family, for example cousins, living in the same house do not qualify as siblings.

4. Children of a member of staff working at the school, where the member of staff has been employed for two or more years.
5. Historical Sibling – Priority will be given to applicants with an older sibling who attended WGSP but has now left within the past 5 years. Sibling means children who live as a brother/sister in the same house and includes natural siblings, adopted siblings, foster siblings and step siblings. Extended family, for example cousins, living in the same house do not qualify as siblings.
6. Child's health reasons. Medical evidence must be provided which demonstrates a specific health reason which requires a child to attend WGSP as their preferred school.
7. Residence in the WGSP School access area. Please see **appendix A** for the map. This can also be found on the Medway Local Authority admissions page.
8. Nearness (see appendix B for definition from LA) of children's homes and ease of access to schools (In the event of a tie within any criterion, before the last criterion, places will be allocated to those living closest to the school measured by the shortest available walking route. 'Distances and routes calculated will represent the shortest route to school from the child's home address using roads and paths that are known to the graphical information software (GIS) utilised by School Admissions & Transport') Evidence of residence may be required. Please see the definition of 'nearness' taken from the Local Authority co-ordinated scheme for secondary admissions 2027/28.

In the event of a tie within any criterion, before the last criterion, places will be allocated to those living closest to the school measured by the shortest available walking route. In the unlikely event that a tie breaker is required for oversubscription criteria 9 the relevant names will be issued with a number and drawn randomly by an independent witness (a governor) to decide which child should be given the place.

In cases of over subscription, parents can ask for the children's names to be placed on a waiting list held by the Local Authority for a place at WGSP School. The children will be ranked according to the schools over subscription criteria and not according to the date when the child's name was added to the list. The Local Authority will hold the waiting list until 31 December 2027 and contact those on the waiting list to advise them on how to then apply to the school as in-year admissions, if they wish to do so.

### **In-Year Admission**

The casual admissions process will follow Local Authority guidelines that aim to make an in-year admission placement within 10 school days. Parents can apply for an in-year admission at any time during the school year. Parents wishing to make an in-year admission should complete the Local Authorities' In Year Casual Application Form (IYCAF). This can be obtained from Medway Council's website. If no places are available at the time of application the parent has right to appeal and/or the option to be added to a waiting list, held by WGSP School. Names are kept in priority order according to the oversubscription criteria and not according to how long a child's name has been on the list. Any place that becomes available will be offered to the child at the top of the list. All vacancies will be allocated as they arise.

If a parent wishes to transfer their child from another school without moving home, the Admissions officer will contact the Child's current school to ascertain the situation so that our school is able to offer the correct support should the child be offered a place. It is also expected that the parent/carer of the child, along with the child themselves, visit our school and meet with the Head of Year or member of Senior Leadership before any place will be offered.

### **Admitting a child into a year group not for their birth year**

The school reserves the right to admit students into a year group that may not include the applicant's birth year group. If any parent wishes to make an application for their child to be admitted to an academic year outside of their child's birth year, the evidence to support the application must be compelling enough to demonstrate that the student is in such need of working below their age range without an EHCP being in place, or is of an ability that is above their age range but chooses not to attend a selective school that the student would not be set work relevant to their academic level.

### **Admission into Year 12**

Places will firstly be offered to children in Local Authority care. i.e. a child under the age of 18 years for whom the Local Authority provides accommodation by agreement with their parents/carers (As per Section 22 of the Children Act 1989 or who is subject of a care order under Part IV of the Act). Priority will be given to existing pupils transferring from Year 11. Pupils are admitted to the Sixth Form subject to the following:

- A formal application by pupil and a pupil interview to determine the courses to be studied
- Availability of a specific course or combination of courses

Pupils maybe offered a trial place in 6th form if the school deems it appropriate.

The school reserves the right to withdraw courses if there is insufficient student demand.

After a place has been offered, the school reserves the right to withdraw the place in the following circumstances:

- When a parent has failed to respond to an offer within a reasonable time; or
- When a parent has failed to notify the school of important changes to the application information; or
- Where it is discovered that the school offered the place on the basis of a fraudulent or intentionally misleading application.

The over-subscription criteria for pupils in Year 7 will also be applied for Year 12.

### **Admissions for Children an Education Health & Care Plan (EHCP)**

The admissions arrangements for children with Education, Health and Care Plans are the responsibility of Medway Council. For advice on arrangements to admit your child into school, you should contact your local SEN Officer through Medway Council.

### **Right of Appeal**

If having applied the oversubscription criteria, the school is unable to offer a place, parents will be contacted in writing and advised of the reason why a place could not be offered. Parents wishing to appeal should write to the Admissions Officer at the school, who will contact the Clerk to the Appeals Panel for the school. The Appeals Panel will then contact the parent with a hearing date at least 10 school days prior to the hearing.
